How is delete function managed in Sage UBS plus?

Why is appropriate management of unwanted transactions important?

All transactions input into the system, wanted or unwanted, should remain as a valid record in the system for traceability as they have the following impact and compliance in the system:



Legality compliance

- Document to be deleted may have been printed and send out/emailed to customer and this means a legal copy of the document is already available in the market. As such, the proper procedure should be issuance of a Credit Note or Debit Note to reflect the change required
- Under the coming Malaysia GST requirement; all records in the system are to remain intact; no document can be deleted (removed) from the system for audit purposes.
- IFRS requirements <u>full convergence by 1st</u>
 Jan 2012

Accounting Concept

- Posted transaction affects accounting records and financial statements.
- In an integrated environment, improper deletion of transaction will affect accounting figures and incur inconsistency between modules, Accounting and Inventory & Billing.
- Costing is calculated run-time; improper deletion of transaction will cause inaccuracy in cost calculation.
- To preserve document numbering integrity, it is good business practice to keep complete record of all transactions. Missing document number will pose a big concern during auditing

In view of the above impact, Sage UBS ^{plus} is designed to enable user to 'delete' unwanted transactions in a more appropriate manner while maintaining data integrity.

How "delete" function is managed in Sage UBS plus depends very much on the status of the transaction as detailed below:
